MOST RESPECTFULLY SHEWETH :-

1. The petitioner has been granted Category II trading license on 03.12.2018 for the period of 25 years under section 14 of EA03 by the Hon'ble Commission . Copy of trading license issued by Hon'ble Commission is annexed herewith as "Annexure I".
2. The present petition is being filed for surrender of the existing trading license under Regulation 14(3) of CERC Regulations, 2009 ( Procedures , Terms and conditions for Grant of Trading License and other related matters ) and amendements there of ( herein referred to as "Regulations") which is reproduced herein below :  
  
"14(3) Where the licensee makes an application for surrender of license , the application shall contain the following information and documents:  
  
(a) Reason for seeking surrenders;  
  
(b) An affidavit to the effect that the licensee has deposited the license fee for the year in which surrender is sought; that there are no undischarged liabilities against the licensee; that there are no operative contracts for trading for trading of electricity to which the applicant is a party at the time of filing the said application;  
  
(c) An affidavit to the effect that the applicant has posted the complete application on its website and shall keep the application uploaded on its website till its disposal by the Commission;  
  
(d) Document showing that the licensee has published the notice about its application for surrender in two daily newspapers having circulation in each of the five regions in addition to those published from Delhi including one economic newspaper;
3. The Petitioner has not undertaken any trading activities since July 2019 . Looking at the future business potential of trading , the Petitioner is not keen to continue its trading business and seeking to surrender its existing trading license .
4. The Petitioner submits that it does not have any undischarged liability against the inter state trading license nor any claims has been raised by any party from past 1 year. The Petitioner also submits that there is no operative contract pending against the license .
5. The Petitioner submits that , it has published notice about its application for surrender of trading license on 3<sup>rd</sup> September 2019 & 4<sup>th</sup> September 2019.
6. The Petitioner submits that, as mentioned here above , it has not undertaken any trading activity at the time of filing of the current application .






